Yes, 'our own' Carol Wright opened the conference with a very moving history of the 25th Anniversary of the ADA. Twenty-five years! It was interesting to me that the ADA movement was not initiated by those with disabilities, but others that saw the unjust treatment of those with limitations. Carol stepped us through the process, reminding us of how very limited and unreasonable many living and mobility conditions were for those with disabilities. This was an exceptional presentation.

*Speaker – Troyce Crucchiola
Kidney dialysis patient for 25 years*

Troyce has been a kidney patient in Portland, OR, for 25 years, experiencing all forms of treatment in that time. Years of in-center hemodialysis, six years plus of peritoneal dialysis, two years of home hemodialysis and transplants have given him great perspective on the "patient experience."

He is now in the transportation industry driving a program to improve transportation for dialysis patients. His story is remarkable.
